

# Privacy Policy

What do we do with your information?

**When you browse our website, we automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.**

**When you register to the website we ask for your name and birthday, both of which can be real or fictional, we leave it up to you what information you provide us in these fields. We also collect your email address. With your permission, we may send you emails about our website, new products and other updates.**

**When you purchase something from our website, as part of the buying and selling process, we collect the personal information you give us such as your name, address, email address, phone number and credit card information. This data is collected to be able to charge you for your purchase and any subscription renewals for any subscription services that you have purchased.**

**We do not share or distribute your personal information outside of our company.**

**The data that you have provided will be stored until you deactivate your account, withdraw consent, you delete it personally or we delete it based on security or personal reasons.**

Consent

**How do you get my consent?**

**When you sign up to our website, provide us with personal information to complete a transaction, verify your credit card, place an order, arrange for a delivery or return a purchase, we imply that you consent to our collecting it and using it for that specific reason only.**

**If we ask for your personal information for a secondary reason, like marketing, we will either ask you directly for your expressed consent, or provide you with an opportunity to say no.**

**How do I withdraw my consent?**

**We may disclose your personal information if we are required by law to do so or if you violate our Terms of Service.**

#### Data Storage

**Our website is hosted with wix.com. They provide us with the online e-commerce platform that allows us to sell our products and services to you.**

**Your data is stored through Wix's data storage, databases and the general applications. They store your data on a secure server behind a firewall.**

**Your credit card data is never stored, and all payments comply with PCI-DSS requirements.**

#### Payment:

**If you choose a direct payment gateway to complete your purchase, then our payment processor stores your credit card data. It is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS). Your purchase transaction data is stored only as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is deleted.**

**All direct payment gateways adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.**

**PCI-DSS requirements help ensure the secure handling of credit card information by our website and its service providers.**

#### Third-Party Services

**In general, the third-party providers used by us will only collect, use and disclose your information to the extent necessary to allow them to perform the services they provide to us.**

**However, certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies in respect to the information we are required to provide to them for your purchase-related transactions.**

**For these providers, we recommend that you read their privacy policies so you can understand the manner in which your personal information will be handled by these providers.**

**In particular, remember that certain providers may be located in or have facilities that are located in a different jurisdiction than either you or us. So if you elect to proceed with a transaction that involves the services of a third-party service provider, then your information may become subject to the laws of the jurisdiction(s) in which that service provider or its facilities are located.**

**As an example, if you are located in Canada and your transaction is processed by a payment gateway located in the United States, then your personal information used in completing that transaction may be subject to disclosure under United States legislation, including the Patriot Act.**

**Once you leave our website or are redirected to a third-party website or application, you are no longer governed by this Privacy Policy or our website's Terms of Service.**
